

## NEWTON ST CYRES 200 CLUB - RULES

1	The name of the club will be NEWTON ST CYRES 200 CLUB (the "Club")		
2	The Bank Account details for the Club are: Account Name: Newton St Cyres Parish Church 200 Club Account Number: 10660434 Sort Code: 20-30-47		
3	Each financial year will run from 1 June to the following 31 May		
4	There will be only 200 members of the Club based on 200 ticket numbers available in any financial year		
5	A year's membership for one ticket number will cost £11.00. the maximum potential revenue from 200 member subscriptions is £2,200.		
6	A part year's membership is permitted if there are spare ticket numbers at the end of the collection period. The cost will be £1 x the number of months remaining in that financial year		
7	Collectors will be allocated to approach individual households and collections for the new financial year will be targeted to have been completed by 31 May having commenced in early April.		
8	When numbers are purchased, the member will receive a certificate with the number and financial year to which it is valid together with the rules of the Club		
9	Preference will be given to those with existing membership and tickets from the previous financial year. Existing members will keep the same number(s) from year to year if they renew their membership. Spare tickets or tickets that are not renewed will be available to any.		
10	Payments can be made in cash, on-line into the Club's bank account (see above) or by cheque (cheques are payable to Newton St cyres Parish Church 200 Club)		
11	Should there be any spare ticket numbers (i.e. not all 200 tickets are purchased), the Club reserve the right to adjust any prizes accordingly		
12	There will be a monthly draw, usually in the first week of each month a during a public event (often a local Coffee Morning) for full transparency of the draws		
13	Ticket numbers will be entered into each monthly draw for which a valid payment has been received		
14	The draw will be made from a container containing 200 balls, each numbered from 1 to 200. The completeness of the set will be validated each year (or if dropped!)		
15	The winning numbers and resulting winning members and the resulting winning prize amount will be communicated to the winning members		
16	Only members' names will be disclosable, and subsequently published in the Newton Wonder (unless requested by the winning member to remain anonymous )		
17	all other personal and banking data will be held securely by the charity under the terms of the Data		
18	Prizes are awarded as follows: (60 opportunities in total)

19	Winners will usually be notified by the Collector who signed them up and will issued the prize in cash.		
20	In the event of any dispute the decision of the administrator and overseer of the 200 Club will be final.		
21	Tickets are non-transferable		
22	In the event of any prize not being claimed, winning funds will be retained by the club		
23	In the event a member wishes to donate their winning prize to a charity they may instruct the club to do so. In such instance they may choose to remain anonymous		
24	Following the last payments in May each year, a payment to Newton St Cyres Church will be made based on the balance of subscription income over prize payments. The maximum payment arising is £1,100		
25	The Newton St Cyres 200 Club is registered as a non-commercial small society lottery under the Gambling		
26	The Club will produce a Return to the Mid Devon District Council no later than three months from the date of the last draw in line with the Small Society Lottery Gambling Act 2005
